GTHAUS MEISTERSCHAFT US / CANADA DEALER POLICIES AND PROCEDURES

MAP Pricing Policy:

As the manufacturer of GTHAUS Meisterschaft systems, we prefer that our dealers sell our products at MSRP pricing. However, we do recognize that some discount may be necessary to satisfy the client. We adhere to a strict MAP (Minimum Advertised Price) Pricing Policy of 5% off MSRP. Any dealer in suspicion of and/or confirmed in violation of the MAP Pricing Policy may have their dealership privileges revoked at any time.

Shipping:

The shipping cost is \$149 per box to anywhere in the United States (excluding Alaska, Hawaii, and Puerto Rico). Drop ship to a client's location (i.e. if different from the dealer) is also available at the same \$149 box rate. Shipping cost to anywhere in Canada is \$250 per box. If the client has an international shipping address, please call for a shipping quote. We do not recommend up selling shipping, as our shipping rates are available on our website.

Additionally, we allow our dealers to arrange their own shipping. In this case, GTHAUS charges a nominal \$49 per box (Packaging and Handling Fee), inclusive of bulk shipments which can be palletized and shipped via freight for convenience and cost savings.

Availability:

As the manufacturer, GTHAUS Sales and Distribution is handled out of our Corporate Office in Bensenville, IL, just outside of Chicago, IL. Our stock changes daily, therefore, please contact us if you have an inquiry. If an item is available at our location, we will be able to ship typically within (1) or (2) business days after payment is received.

If an item is not in stock, we may have a shipment currently under production, currently inbound on ocean freight, currently inbound on air freight, or the product may have to go into full production. Lead time will vary based on the situation.

Ordering / Prepayment Policy:

To place an order, we require prepayment in full with a full understanding of our Sales Order Cancellation Policy. Prepayment in full is required whether or not the product(s) is in stock, in production or needs to go into production. We accept only U.S. based credit cards or bank wire transfers. If you chose to make payment by wire transfer, bank information (bank name, address, SWIFT code, ABA routing number and account number) needed to make payment will be provided within the Sales Order pertaining to your purchase at the time your order is placed.

Cancellation / Return Policy:

GTHAUS does not accept unauthorized returns. To return an item, a Return Merchandise Authorization (RMA) must be requested from the sales department and approved. All returns must be shipped back to GTHAUS in new, unused condition and original packaging within thirty (30) days of delivery. Returns are subject to a 20% restocking fee.

Returns will not, however, be accepted for used or special order items, electrical devices or items which have been modified in any way – no exceptions will be made.

Warranty Policy:

Dealers are responsible for keeping all sales order records for warranty purposes. We offer a 5-year warranty on our stainless steel systems and a 1-year warranty on our titanium systems. GTHAUS Meisterschaft product warranty is not transferable and original purchase documents must be verified.

Defective items must be returned to our facility located in Bensenville, IL for replacement in accordance with our return policy. Shipment cost(s) will be at the buyer's expense. We will replace all defective items that meet our requirements, but will not accept any liability for loss or inconvenience caused by their use or failure. We reserve the right to withhold issuance of credit until returned defective part has been examined and tested.

Exclusions & Limitations:

- Any product, which has been subjected to abuse, accident, alteration, neglected maintenance or improper installation, renders the product warranty null and void.
- Conditions resulting from acts of nature, weather, criminal activity or accidents are subject to adjustment under the product warranty.
- There is no warranty, expressed or implied, on any parts modified and/or used for competition or track events.
